

## Norfolk & Waveney Agreed Fair Usage Policy Stoma Miscellaneous Appliances

This policy has been developed in collaboration with Clinical Nurse Specialists at The Queen Elizabeth Hospital King's Lynn, The Norfolk & Norwich University Hospital, The James Paget University Hospital and local community stoma nurses.

- **New products/samples should ONLY be initiated by Hospital/Community Stoma Team.**
- **Retrospective & prospective prescription requests for new items from dispensers should be declined eg samples provided to patients as they may not be clinically appropriate.**
- **GP Practices should ensure they have written confirmation from a Hospital/Community nurse prior to issuing a prescription.**
- **Please ensure double quantity prescriptions are not released for holiday seasons.**

<b>Adhesive Removers Sprays</b>	<b>Sprays are more cost effective than wipes. Generally, prescribe one type but might need occasional both spray/wipes as directed by stoma nurse.</b>

<b>Adhesive Remover Wipes</b>	<b>Wipes may be more suitable for people with poor dexterity or two-piece stoma bags.</b>		
	Lifteez 60321 Salts wipes WAP2	1 single wipe per pouch (1 box per 30 pouches)	
<b>Barrier Wipes (films, foams sticks)</b>	<b>Short-term use only via Clinical Nurse Specialist (usually 3 months) All barrier preparations are on specialist advice.</b>		
	Medicare Derma S wipes 60307 Salts wipes PPS1 Guard non-sting film sachets RMC3 Independence Fusion applicator BW2	One pack for every 30 bags based on clinical need as assessed by Nurse BW2 not to be routinely used	
<b>Barrier Sprays</b>	<b>For peri-anal soreness, anal dilation soreness, peristomal breakdown.</b>		
	Pelican Platinum with Vit E 130200E Cavilon pump spray 28ml 3346P	1 bottle per 30 bags	
<b>Other Barriers e.g. creams</b>	<b>For mucocutaneous hypersensitivity, Cancer patients &amp; complex dermatological conditions.</b> <b>The ICB does NOT support the prescribing of SACHETS these are classified on the traffic light system as BLACK i.e., not for primary care prescribing.</b>		
	Medi Derma-S Barrier Cream 90g 60345 Pelican Barrier cream 60g 130100E Guard Barrier Cream 60g RMC1	As per clinical letter	
<b>Discharge Solidifying gels</b>	<b>Sometimes described as thickening gels. Consider second and third line in patients with chemotherapy induced diarrhoea, jejunostomy</b>		
	Essenta Diamond sachets 420791 Absorb Neutralising sachets PFW6	1 box per 30 bags.	
<b>Irrigation Kits accessories</b>	<b>Complete kits provided by Trust Stoma nurses. GP to prescribe replacement accessories.</b>		
	Coloplast OR Dansac including accessories	These should last up to 6 months. Please refer to spiel above	
<b>Lubricating gels</b>	<b>Lubricating deodorising gels via clinical nurse specialist. These are used as a lubricant, not deodoriser as they help to reduce pancaking. The ICB does not support the prescribing of the sachets</b>		

	Brava lubricating Bottle Adapt	<b>12061</b> <b>78500</b>	1 bottle lasts approximately 3 months
<b>Seals /Barrier Rings</b>	<b>These are mouldable and help prevent leaks.</b> <b>PS Check to see if still needed before issuing a repeat prescription</b>		
	Eakin Brava Adapt	<b>All codes</b> <b>All codes</b> <b>All codes</b>	30 per month i.e.one per pouch

<b>Stoma Paste</b>	<b>Pastes are used to create an even surface immediately next to the stoma this gives a good seal and helps to prevent leakages.</b>		
	Convatec Paste Salts Dansac Soft Paste	<b>S105</b> <b>NSP1</b> <b>77550-0</b>	As per Specialist recommendation from Stoma Team
<b>Support Wear</b>	<b>Levels 2- 3 belts are supported by the ICB. These should only be prescribed following an assessment by Clinical Nurse Specialist.</b> <b>The ICB does <b>not</b> support the prescribing of Level 1 support undergarments or vests</b>		
	All Brands		Maximum 3 per year
<b>Flange extenders</b>	Genii (Trio) Flange Extender	<b>TR1060</b>	Amount as per clinical letter
	Brava Elastic Tape Respond comfort flange extender	<b>All codes</b> <b>All codes</b>	
<b>Ileostomy bags</b>	<b>The ICB does <b>not</b> support the prescribing of flushable bags</b>		
	Drainable bags		20-30 bags per month
<b>Colostomy bags</b>	<b>The ICB does <b>not</b> support the prescribing of flushable bags</b>		
	Non-drainable bags		Up to 90 bags per month
<b>Urostomy bags</b>	<b>The ICB does <b>not</b> support the prescribing of flushable bags</b>		
	These are drainable & will need matching manufacturer's night drainable bags (see below)		20-30 bags per month
<b>Night drainage bags</b>	This information is relevant for urostomy patients, <i>not continence</i>		
	Matching Manufacturers (see above)		5 bags per month.

<b>Stoma caps</b>	All brands	30 caps per month
<b>Anal Plugs</b>	All brands	30 plugs per month

<b>Deodorants</b>		ALL aerosols and odourising drops
<b>General Skin Cleansers / Liquids</b>		<i>ALL - Patients should use warm water and soap to clean their hands and area around stoma or should purchase as per the NHS self-care agenda.</i>
